The Blue Angel is Germany's most well-known environmental label. You can thus benefit from the clear competitive advantages and added level of trust that this environmental label enjoys in the economy and amongst consumers. The label's credibility and competence, its objective criteria, its institutionalised award process and its governmental links increase your corporate and brand value.

The advantage of the Blue Angel

The Blue Angel allows you as a company to present your environmental management practices and product responsibility in a credible way and set yourself apart from your competitors. Furthermore, you can use the Blue Angel for textiles to demonstrate to customers that you

- observe high environmental standards in the manufacturing process,
- · improve occupational safety and social conditions in manufacturing,
- · avoid harmful chemicals in the end product, and
- · ensure good usability.

Unbeatable product variety

The following products made from at least 90 weight percent textile fibres can be certified with the Blue Angel:

- Textile clothing and textile accessories
- House and home textiles
- · Functional clothing
- · Technical textiles
- Bed linen
- · Bedding (e.g. pillows and duvets)
- Cleaning textiles: woven or non-woven textiles
- Fibres, yarn, woven fabrics, knitted or crocheted fabrics and nonwovens (including textile composites)

Also in the variety of materials, the Blue Angel for textiles is unbeatable:

- Natural fibres (cotton, flax, hemp, linen, kapok, wool and silk)
- Chemical fibres (polyacrylic, elastane, polyamide, polyester, polylactide and polypropylene)
- Regenerated cellulose fibres (lyocell, modal and viscose)

Ecological and fair - right from the start

The Blue Angel criteria for textiles consider the entire manufacturing process and reflect all processes relevant to the environment and health. At its core the Blue Angel is an ecolabel, but consumers are also increasingly scrutinising working conditions in production, therefore, in addition to the classical environmental requirements social aspects for textile production are taken into account.

Criteria: What does the Blue Angel for textiles take into consideration?

- · Use of 100 % organic cotton
- · Use of tested chemical fibres
- · Avoidance of substances that are harmful to health and environment e.g. via
 - » Strict regulation of flame retardants
 - » Exclusion of Cerium compounds, as well as perfluorinated and polyfluorinated chemicals
 - » Strict regulation of biocides
 - » Strict regulation of softening agents (phthalates)
 - » Strict limits for heavy metals
- · Reduction of wastewater emissions, as well as in emissions to air
- · High usability
- · Certified social standard

Compliance verification

Compliance with all requirements must be verified in accordance with the Basic Award Criteria – e.g. in the form of test reports, approved certificates or legally binding manufacturer declarations.

- · the Partnership for Sustainable Textiles
- the ZDHC-MRSL Zero Discharge of Hazardous Chemicals Manufacturing Restricted Substances List
- the Best Available Techniques of the Textile Industry

Use of the environmental label is limited to the period of validity of the Basic Award Criteria. The current Basic Award Criteria are valid until 31/12/2022. RAL gGmbH – the awarding body for the environmental label – will charge a one-off handling fee of 400 Euro for the application. The annual fee is based on the annual sales of the certified product.
